The package includes:

1. An account application for Primavera Interior Furnishings
2. A credit card authorization form if you wish to remit payment by Visa (all suppliers), MasterCard (all suppliers) or AMEX (Primavera only)

To begin, you will need to complete only the Primavera account form. Some of the companies we represent do invoice our clients directly and if you wish to purchase product from one of them, you will also need to complete their individual account application forms. In this package you will also find:

- An account application for the O&L, Osborne & Little Group (including Designers Guild, Nina Campbell, Ralph Lauren, Christian Lacroix and Osborne & Little). All O&L orders are billed directly in CDN dollars by O&L (Connecticut, USA) and shipped directly from London, England.
- An account application for the PF, Pierre Frey Group (including Boussac, Fadini Borghi, Pierre Frey, Thorp of London and Braquenie). All PF orders are billed directly in CDN dollars by Pierre Frey (Atlanta, USA) and shipped directly from Paris, France.
- An account application for JAB (including Jab, Chivasso & Carlucci). All JAB orders are billed directly in CDN dollars by Jab USA (New York, USA) and shipped directly from Germany.

****Note: you will need to fill out a separate credit card authorization form if you wish to pay by Visa (all suppliers), MasterCard (all suppliers) or AMEX (Primavera only).**

Please also note that all orders must be provided to us **IN WRITING**. This requires that a written Purchase Order or an order request be sent by Email, Fax or Mail. This must include Style # & Name, Colour # & Name, Quantity, Bill to Address & Ship To Address.
